The Pike County Commission met in a regular session on September 9, 2024, at 5:15 P.M. in the main auditorium of the Pike County Courthouse Annex – Pike County Health Department Building at which time the following members were present: Chairman Chad Copeland, Commissioners Homer Wright, Robin Sullivan, Jimmy Barron, and Cynthia S. Pearson. Commissioner Russell Johnson was absent.

Commissioner Barron made a motion to approve the August 26, 2024, meeting minutes, as presented. Commissioner Pearson seconded the motion and all voted yea.
