The Pike County Commission met in a regular session on October 15, 2024, at 5:15 P.M. in the main auditorium of the Pike County Courthouse Annex – Pike County Health Department Building at which time the following members were present: Chairman Chad Copeland, Commissioners Homer Wright, Robin Sullivan, Jimmy Barron, and Cynthia S. Pearson. Commissioner Russell Johnson was absent.

Commissioner Barron made a motion to approve the September 23, 2024, meeting minutes, as presented. Commissioner Wright seconded the motion and all voted yea.

Commissioner Pearson made a motion to approve the claims as presented. Commissioner Sullivan seconded the motion and all voted yea.

Commissioner Wright made a motion to approve the County Engineer’s request to approve the completion of probation and classification of county employee, John Rodgers, as a permanent part-time Equipment Operator I, and to approve the hiring of Penny Zingre as a full-time Equipment Operator I at a Grade C, Step 2. Commissioner Barron seconded the motion and all voted yea.

Commissioner Pearson made a motion to approve the Fire Alarm System Test and Inspection Agreement with Harris Security Systems for the EMA/911 building. Commissioner Sullivan seconded the motion and all voted yea.

Commissioner Wright made a motion to approve the County Administrator’s request to approve the new job description, Facilities Manager, at a Class Grade “O”, and to advertise for this position. Commissioner Sullivan seconded the motion and all voted yea.

Commissioner Barron made a motion to adjourn the meeting. Commissioner Pearson seconded the motion and all voted yea.
